

**AMENDMENT TO THE AGREEMENT FOR BUILDING INSPECTION SERVICES  
BETWEEN THE CITY OF HERCULES AND CONTRA COSTA COUNTY**

This Amendment to the Agreement for Building Inspection Services ("Agreement") is entered into between the City of Hercules ("City") and Contra Costa County ("County") for building inspection and code enforcement services to be provided by the County for the City.

1. The Agreement is amended as follows:

- A. The existing "Revised Exhibit A 2020, DCD Hourly Billing Rates for FY 2020-21, 2021-22, 2022-23" is hereby deleted and replaced with the "Revised Exhibit A 2024, DCD Hourly Billing Rates for FY2024-25, 2025-26, 2026-27".
- B. Accordingly, in Section 3.A.1. and Section 3.B. of this Agreement, the reference of "Revised Exhibit A 2020 to this Agreement" is deleted and replaced with "Revised Exhibit A 2024 to this Agreement".
- C. Accordingly, in Section I.B.3. and Section II.C. of Attachment A to this Agreement, the reference of "Revised Exhibit A 2020" is deleted and replaced with "Revised Exhibit A 2024".

2. All remaining terms of the Agreement as previously amended, not amended by this Amendment shall remain in full force and effect.
