HERCULES CITY COUNCIL RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HERCULES, CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE CITY'S DECEMBER 3, 2024 PROFESSIONAL SERVICES AGREEMENT WITH SNG & ASSOCIATES, INC. TO PROVIDE CONSTRUCTION MANAGEMENT, INSPECTION AND QUALITY ASSURANCE TESTING SERVICES FOR THE FALCON WAY PAVEMENT REHABILITATION PROJECT, INCLUDING WREN COURT AND FINCH COURT ADDITIONS TO THE SCOPE OF THE PROJECT, INCREASING THE COST BY \$109,169 TO A TOTAL COST OF \$168,289.

WHEREAS, On December 3, 2024, the city entered into an agreement in the amount of \$59,120 for professional services with SNG & Associates, Inc. (SNG) to prepare the design of the Falcon Way Pavement Rehabilitation between Wren Court and Refugio Valley Road; and

WHEREAS, During the 95 percent design review, at the request of the City, SNG incorporated the design of alternate bid items for a cape seal application (an asphalt-rubber chip seal layer followed by a slurry seal surface coat) for two road segments peripheral to Falcon Way that were identified in poor (Wren Court) and very poor (Finch Court) condition in the 2022 pavement condition assessment; and

WHEREAS, On September 2, 2025, the City received bids for the Falcon Way Pavement Rehabilitation Project, with MCK Construction, Inc. submitting the low bid, inclusive of the two alternate bid items; and

WHEREAS, The City anticipates continued need for SNG's services to support management of the construction for this project inclusive of Construction Management, Inspection Services, Post-Construction Closeout and Quality Assurance and Laboratory Testing.

WHEREAS, There is sufficient funding in the Adopted FY 2025-26 Budget to fully fund the construction and construction management services; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hercules as follows:

1. The City Council hereby authorizes the City Manager to amend the contract with SNG to provide Construction Management, Inspection and Quality Assurance Testing Services for the Falcon Way Pavement Rehabilitation Project, including Wren Court and Finch Court Additions to the Scope of the Project, Increasing the Cost by \$109,169 to a Total Cost of \$168,289.
