**SUBJECT:** Approval of the Encroachment Easement and Agreement for Block N of

the Bayfront Project

#### **RECOMMENDED ACTION:**

Adopt a resolution approving the Encroachment Easement and Agreement for Block N of the Bayfront Project and authorizing the City Manager to execute said Agreement on behalf of the City Council.

#### FISCAL IMPACT OF RECOMMENDATION:

There are no fiscal impacts associated with the approval of the final map.

#### **DISCUSSION:**

In June of this year Council approved the Final Map for Block N, which is a triangular, 2.2 acre lot bounded by John Muir Parkway to the east, Bayfront Boulevard to the north, and Refugio Creek to the south. A multi-family, mixed use retail development has been approved for this site and is in building plan review with an anticipated construction start date as soon as January 2018.

The Encroachment Easement and Agreement grants the property owner (i.e. developer) rights to construct and maintain overhead structures such as building arcades and shopfront awnings on the second floor that will encroach 5-12 feet into the public rights of way on John Muir Parkway and Bayfront Boulevard. The easement was included in the approved vesting tentative map and the overhead structures are included in the approved project as well as the Hercules Waterfront District Master Plan guiding document.

#### ENCROACHMENT EASEMENT AND AGREEMENT

STATE OF CALIFORNIA CONTRA COSTA COUNTY CITY OF HERCULES

THIS ENCROACHMENT EASEMENT AND AGREEMENT (this "*Easement*") is made, dated, and entered into as of the \_\_\_\_ day of \_\_\_\_\_, \_\_\_\_, by and between the City of Hercules, a California municipal corporation ("*City*"), and Hercules Development Partners a limited partner company ("*HDP*").

#### RECITALS

- A. City is the owner of that certain real property located in the City of Hercules and identified as Lot 26, John Muir Parkway, and Lot 34, Bayfront Boulevard, (collectively, "Lots 26 & 34"), which lots are a portion of "Parcel D" as said parcel is shown on that certain map entitled "Parcel Map MS 476-00," filed October 12, 2000, in Book 179 of Parcel Maps 38, 39, and 40 (179 PM 38) ("Parcel D"), in the office of the Contra Costa County Recorder; and
- B. HDP is the owner of that certain real property located in the City of Hercules identified as Lot 25, which is also a portion of Parcel D, as more particularly described on **Exhibit A** attached hereto and incorporated herein by this reference (the "**HDP Lot**"), upon which the HDP's mixed-use building (the "**HDP Building**") shall be located; and
- C. HDP desires to construct exterior overhead frontage structures of types that may include a building arcade or shopfront awning on the second floor and above on the HDP Building facing northeast towards Lot 26 and northwest towards Lot 34 (collectively, the "*HDP Overhead Structures*," and each individually a "*HDP Overhead Structure*"); and.
- D. Each HDP Overhead Structure will encroach onto Lots 26 & 34 as depicted on **Exhibit B** attached hereto and incorporated herein by this reference; and
- E. City, as the owner of Lots 26 & 34, desires to grant certain easement rights over Lots 26 & 34 in order to allow HDP, as the owner of the HDP Lot, to install, maintain, repair, replace and use the HDP Overhead Structures; and

F. HDP, as the owner of the HDP Lot, desires to execute this Easement for the purpose of acknowledging the terms of its use of Lots 26 & 34 for the installation, maintenance, repair, replacement and use of the HDP Overhead Structures.

#### <u>AGREEMENT</u>

NOW, THEREFORE, in consideration of the premises; to enhance and protect the value of Lots 26 & 34 and the HDP Lot; and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, City does hereby grant, bargain and convey unto HDP, its successors, heirs and assigns, the following easements, rights, covenants and undertakings pursuant to which Lots 26 & 34 and the HDP Lot shall be owned, conveyed, transferred, occupied and used:

- 1. <u>Incorporation of Recitals</u>. The foregoing Recitals A through F shall constitute an integral part of this Easement, and this Easement shall be construed in accordance therewith.
- 2. <u>Establishment of HDP Overhead Structures Easement</u>. City hereby grants, bargains, and conveys to HDP, as owner of the HDP Lot, a non-exclusive, perpetual right, privilege and easement to install the HDP Overhead Structures over Lots 26 & 34 in the locations shown on Exhibit B, attached hereto and incorporated herein by this reference (the "*HDP Overhead Structures Easement*").

The HDP Overhead Structures Easement shall include, but not be limited to, the right of construction, maintenance, repair, use and operation of the HDP Overhead Structures by HDP within the portion of Lots 26 & 34 shown on Exhibit B. The HDP Overhead Structures shall be considered a portion of the HDP Building for *ad valorem* property tax purposes.

3. Maintenance of HDP Overhead Structures. The owner of the HDP Lot shall be solely responsible for the maintenance, repair and replacement of the HDP Overhead Structures. The City shall have the right to enter the building located upon the HDP Lot in order to inspect the HDP Overhead Structures after providing reasonable prior written notice to the owner of the HDP Lot, unless the City has reasonable cause to believe that a health or safety risk to Lots 26 & 34 is posed by the HDP Overhead Structures, in which case no prior notice shall be required, but City shall inform the owner of the HDP Lot thereof in writing as soon as reasonably possible thereafter. Should HDP fail to repair the HDP Overhead Structures within thirty (30) days after receipt of written notice (or such longer period of time as is reasonably necessary, so long as HDP promptly commences and diligently pursues the repair), or in the case of a health or safety risk to Lots 26 & 34, ten (10) days (or such longer period of time as is reasonably necessary, so long as HDP promptly commences and diligently pursues the repair), the City shall have the right to take reasonable measures to eliminate the health or safety risk posed to Lots 26 & 34. The owner of the HDP Lot shall be responsible for the actual, out-of-pocket costs of such measures, and the provisions of Section 4 herein may also be applicable. Exercising this right shall not limit or waive any other rights or remedies the City may have under this Easement.

#### 4. <u>Insurance and Indemnification.</u>

a. <u>Insurance</u>. The owner of the HDP Lot agrees to maintain, on a primary basis and at is sole expense, at all times during the life of this Agreement the following applicable coverages and limits. The requirements contained herein, as well as City's review or acceptance of insurance maintained by the owner of the HDP Lot is not intended to and shall not in any manner limit or qualify the liabilities or obligations assumed by the owner of the HDP Lot under this Agreement.

<u>Commercial General Liability</u> – Combined single limit of no less than \$1,000,000 each occurrence and \$2,000,000 aggregate. Coverage shall not contain any endorsement(s) excluding nor limiting Product/Completed Operations, Contractual Liability or Cross Liability. The owner of the HDP Lot shall endorse the City as an Additional Insured on the Commercial General Liability policy. The Additional Insured endorsement shall read 'City of Hercules as its interest may appear'.

<u>Umbrella or Excess Liability</u> – Annual Aggregate limits on Umbrella of Excess Liability policies shall not be less than the highest 'Each Occurrence' limit for required policies. The owner of the HDP Lot shall endorse City of Hercules as an 'Additional Insured' on the Umbrella or Excess Liability policy, unless the Certificate of Insurance states the Umbrella or Excess Liability provides coverage on a "Follow-Form" basis.

Certificate of Insurance – The owner of the HDP Lot shall provide a Certificate of Insurance to City evidencing that all coverages, limits and endorsements required by this Easement are maintained and in full force and effect. If the owner of the HDP Lot receives a non-renewal or cancellation notice from an insurance carrier affording coverage required herein, or receives notice that coverage no longer complies with the insurance requirements herein, the owner of the HDP Lot shall notify the City within five (5) business days with a copy of the non-renewal or cancellation notice, or written specifics as to which coverage is no longer in compliance. The Certificate Holder address should read:

b. <u>Indemnification</u>. To the maximum extent allowed by law, the owner of the HDP Lot shall defend, indemnify, and hold harmless Indemnitees (hereinafter defined) from and against all Charges (hereinafter defined) that arise in any manner from, in connection with, or out of this Easement as a result of acts or omissions of the owner of the HDP Lot or its contractors or anyone directly or indirectly employed by any of them, or, as determined by a court of law, anyone for whose acts any of the forenamed may be liable. In performing its duties described in the preceding sentence, the owner of the HDP Lot shall at its sole expense defend Indemnitees with legal counsel reasonably acceptable to City. Notwithstanding the foregoing, in no event shall the owner of the HDP Lot be required to defend, indemnify or hold harmless the Indemnities for any Charges arising directly as a result of the negligence or willful misconduct of any of the

Indemnitees. As used in the preceding sentences of this paragraph: (i) "Charges" means claims, judgments, costs, damages, losses, demands, liabilities, fines, penalties, settlements and expenses included without limitation within interest and reasonable attorneys' fees assessed as part of any such item; and amounts for alleged violations of environmental laws, regulations, ordinances, rules, or orders, and (ii) "Indemnitees" means City and its officers, officials, agents, and employees, excluding the owner of the HDP Lot. Nothing in this Section 4(b) shall affect any warranties, rights or duties in favor of the City that are otherwise provided in or arise out of this Easement. This Section 4(b) is in addition to and shall be construed separately from any other indemnification provisions that may be in this Easement. This Section 4(b) shall remain in force despite termination of this Easement (whether by expiration of the term or otherwise).

- 5. Covenants Running with the Land. The HDP Overhead Structures Easement and the easements, rights, covenants and undertakings contained within this Easement shall run with the land and be appurtenant to, and for the benefit of, the owner of the HDP Lot and shall be a burden upon the title to Lots 26 & 34. Any conveyance of the HDP Lot or Lots 26 & 34, or any portions thereof, shall be subject to the HDP Overhead Structures Easement and the easements, rights, covenants and undertakings contained in this Easement, and, at the time of conveyance, the grantor in any deed of conveyance shall be relieved of future obligations thereafter arising by the owners of the lot or property interest so conveyed, but the grantor in any deed of conveyance shall not be relieved of obligations that are based on acts, omissions, or events that occurred before the time of conveyance. Any grantee of HDP or the City, as applicable, or their successors, heirs, or assigns, by recordation of a deed or other instrument of transfer or conveyance, shall be deemed to have assumed the obligations under this Easement with respect to such lot (Lot 26, Lot 34, and/or the HDP Lot, as the case may be).
- 6. Amendment and Termination. This Easement may be modified, amended or terminated only by written agreement of the owners of the HDP Lot and the owners of Lots 26 & 34, and shall be duly acknowledged in a manner suitable for and effective upon recording in the Office of the Register of Deeds of Contra Costa County, California. In addition, should the HDP Overhead Structures be removed and not replaced by the owner of the HDP Lot (or its authorized agents) for a period of ten (10) consecutive years, this Easement shall be terminated upon recording a notice of termination in the Office of the Register of Deeds of Contra Costa County. This Section 6 is subject to Section 13 (Performance of Government Functions).
- 7. <u>Governing Law</u>. This Easement shall be governed by and construed in accordance with the laws of the State of California without regard to principles of conflict of laws.
- 8. No Public Dedication; No Third Party Beneficiaries or Consents. This Easement is not intended, and shall not be construed: (a) as a dedication to the public of any interests in the HDP Overhead Structures described herein, (b) to give any member of the public, or any person, entity, or party other than as provided herein, any right whatsoever herein or therein or (c) to require any consent or other action of any other person, entity, or party other than as expressly provided herein to any amendment to or waiver of any provision of this Easement.
- 9. <u>Severability</u>. This Easement is intended to be performed in accordance with, and only to the extent permitted by, all applicable laws, ordinances, rules and regulations. If any provision of this Easement or the application thereof to any person or circumstance shall, for any

reason and to any extent, be invalid or unenforceable, but the extent of such invalidity or unenforceability does not destroy the basis of the bargain expressed herein, the remainder of this Easement and the application of such provision to other persons or circumstances shall not be affected thereby, but rather shall be enforced to the greatest extent permitted by law.

- 10. <u>Compliance Certificate</u>. Upon the written request of the owner of the HDP Lot or Lots 26 & 34, or the holder of any first lien deed of trust or first lien mortgage on any such parcel, any such owner shall execute, have acknowledged and deliver a certificate stating whether, to the knowledge of the signatory party, the requesting party is otherwise in compliance with this Easement.
- Maiver. This Easement may not be waived orally or impliedly, but only by written document executed by the party against which such waiver is sought. Neither the failure of a party to complain of any violation of this Easement, regardless of how long such failure continues, nor the failure of a party to invoke (or the election by a party not to invoke) any right, remedy or recourse for a violation hereof, shall waive the rights, remedies and recourses of the party with respect to such violation. No waiver by a party of any provision of this Easement shall be deemed to be a waiver of any other provision hereof.
- 12. <u>Rights Cumulative</u>. All rights, powers and privileges conferred hereunder shall be cumulative and in addition to, and not to the exclusion of, those provided at law or in equity.
- 13. <u>Performance of Government Functions</u>. Nothing contained in this Easement shall be deemed or construed to in any way estop, limit, or impair the City from exercising or performing any regulatory, policing, legislative, governmental, or other powers or functions, including the power of eminent domain.
- 14. <u>Authority to Perform</u>. City covenants that it has done nothing to impair title to Lots 26 & 34 in any manner that would impair, in part or in whole, City's ability to perform its obligations under this Easement.
- 15. <u>Counterparts</u>. This Easement may be executed in one or more counterparts, each of which shall be deemed to be an original and all of which taken together shall be considered as one and the same instrument.
- 16. <u>Headings</u>. The paragraph headings in this Easement are for convenience only, and shall in no way define or limit the scope or content of this Easement, and shall not be considered in any construction or interpretation of this Easement or any part thereof.

#### 17. Notice.

a. All notices and other communications required or permitted by this Easement shall be in writing and shall be given either by personal delivery, fax, or certified United States mail, return receipt requested, addressed as follows:

- b. A change of address, fax number, or person to receive notice may be made by either party by notice given to the other party. Any notice or other communication under this Easement shall be deemed given at the time of actual delivery, if it is personally delivered or sent by fax. If the notice or other communication is sent by United States mail, it shall be deemed given upon the third calendar day following the day on which such notice or other communication is deposited with the United States Postal Service or upon actual delivery, whichever first occurs.
- 18. <u>Confirmation of Grant of Easement</u>. City as grantor hereby expressly grants to HDP as grantee the Overhead Structures Easement and all privileged and appurtenances thereunto.





**SUBJECT:** Approval of the 2017 Speed Survey and Adoption of an Ordinance to

Reduce Speed Limits on Sections of Sycamore Avenue and Refugio Valley

Road

#### **RECOMMENDED ACTION:**

It is recommended the City Council:

- 1) Adopt a resolution approving the 2017 Speed Survey; and
- 2) Waive the second reading and adopt an ordinance to amend Hercules Municipal Code Title 3, Chapter 4 to reduce the speed limit on Refugio Valley Road from 40 mph to 35 mph between Redwood Road and Bonaire Avenue and to reduce the speed limit on Sycamore Avenue from 40 mph to 35 mph between Civic Drive and Palm Avenue.

#### FISCAL IMPACT OF RECOMMENDATION:

There is no additional cost associated with this action. Gas Tax funding to replace regulatory signs including speed limit signs is included in the adopted FY 2017-18 Budget.

#### **DISCUSSION:**

#### **Summary**

The speed survey and ordinance were introduced at the November 14, 2017 Council meeting. In accordance with the discussion that occurred, the ordinance remains unchanged while the speed survey has been modified to include minor edits and the full appendix. Once the ordinance is in effect, traffic enforcement officers will be given a binder containing all related items including the resolution approving the speed survey that they can take to traffic court and submit into evidence if a speeding ticket is challenged.

#### **Background**

The 2017 Speed Survey recommends existing speed limits on all City streets remain the same, except for reductions from 40 mph to 35 mph on sections of Refugio Valley and Sycamore. Per the California Vehicle Code (CVC), speed limit reductions must be adopted by ordinance. The 2017 Speed Survey and ordinance were introduced at the November 14, 2017 Council meeting and are now recommended for approval and adoption, respectively.

#### **Detailed Discussion**

The primary purpose of the 2017 Speed Survey is to justify the use of radar for speed limit enforcement as enforcement helps ensure streets are safe for all users. For radar speeding tickets to be valid in traffic court, the California Vehicle Code requires busier or "non-local" roads as defined by the California Road System (*Appendix C of Speed Survey*) undergo a Speed Survey every 5 years (*CVC Section 40802 (a)(2)/Pg. 11 of Speed Survey*). For Hercules, these non-local roads are San Pablo, Willow, Sycamore, and Refugio Valley. The 2017 Speed Survey analyzed these streets and justifies keeping the existing speed limits the same, except for reductions from 40 mph to 35 mph on Refugio between Redwood & Bonaire and on Sycamore between Civic & Palm (*Table 2, Pg. 7 of Speed Survey*).

The remaining streets in Hercules are categorized as local streets under the California Road System and have a default or "prima facie" speed limit of 25 mph per the CVC (Section 22352 (b)(1)/Pg. 9 of Speed Survey). The vast majority of streets in Hercules, including residential streets, fall in this category. Local streets are not subject to the 5 year speed survey requirement (Section 40802 (b)(1)/Pg. 11 of Speed Survey) and so are not studied in the Speed Survey.

Reducing or increasing speed limits on any City street (i.e. local and non-local) can occur if justified by a speed survey and established by ordinance (CVC Section 22357/Pg. 10 of Speed Survey). Once a speed limit is changed, it must also be justified every 5 years through a radar speed survey. The City previously increased speeds on local streets in the Business Park (including Alfred Nobel Drive and Linus Pauling Drive), and sections of Coronado Street and Turquoise Drive. These changed speed limits are codified in Hercules Municipal Code Title 3, Chapter 4 (Attachment 2). The 2017 Speed Survey analyzed these streets and also recommends keeping the existing speed limits (Table 2/Pg. 7 of Speed Survey). As discussed above, the ordinance introduced tonight is to reduce speed limits from 40 mph to 35 mph on sections of Refugio and Sycamore and is justified by the Speed Survey.

Once the ordinance is adopted and the 2017 Speed Survey is approved by City Council resolution, traffic enforcement officers will be given a binder containing all related items that they can take to traffic court and submit into evidence if a speeding ticket is challenged.

#### INTRODUCTION

This Engineering and Traffic Survey is intended to be the basis for the establishment, revision, and enforcement of speed limits for selected streets within the City of Hercules. This Engineering and Traffic Survey presents recommended speed limits for 15 street segments in the City of Hercules. Engineering and Traffic Surveys are required by the State of California to establish intermediate speed limits on local streets and to enforce those limits using radar or other speed measuring devices. These surveys must be updated every 5 or 7 years to ensure the speeds reflect current conditions as dictated by the California Vehicle Code (CVC). The CVC also requires that the surveys be conducted based on the methodology required by the California Manual on Uniform Traffic Control Devices (California MUTCD) dated November 2014.

The survey was requested by the City for the proper posting of speed limits and to enable the Hercules Police Department to utilize radar or other electronic speed measuring devices for speed enforcement. CVC Sections 40801 and 40802 require Engineering and Traffic Surveys that verify the prima facie speed limit before enforcement by such a device is legal. The law further specifies that these surveys be conducted every 5 years. The surveys can be extended to 7 years provided the City's officer(s) have completed a 24-hour radar operator course [CVC 40802(c)(2)(B)(i)(I)]. Additionally, some surveys may be extended to 10 years if a traffic engineer certifies that no changes in roadway or traffic conditions have occurred [CVC 40802 (c)(2)(B)(i)(II)]. These provisions assure that posted speed limits are kept reasonably current.

The Engineering and Traffic Surveys for the City were conducted in accordance with procedures outlined in the California MUTCD and as required by Section 627 of the CVC. The CVC further describes three elements of an engineering and traffic survey:

- Measurement of prevailing speed;
- 2. Collision history; and
- 3. Roadway characteristics not readily apparent to the motorist.

Posted speed limits are established primarily to protect the general public from the reckless and unpredictable behavior of dangerous drivers. They provide law enforcement with a clearly understood method to identify and apprehend violators of the basic speed law (CVC Section 22350). This law states that "No person shall drive a vehicle on a highway at a speed greater than is reasonable or prudent having due regard for weather, visibility, the traffic on, and the surface and width of the highway, and in no event at a speed which endangers the safety of persons or property." The posted speed limit gives motorists a clear warning of the maximum speed that is reasonable and prudent under typical driving conditions.

The basic fundamentals for establishing speed limits recognize that the majority of drivers behave in a safe and reasonable manner, and therefore, the normally careful and competent actions of a reasonable driver should be considered legal. Speed limits established on these fundamentals conform to the consensus that those who drive the highway determine what speed is reasonable and safe, not on the judgment of one or a few individuals. A radar speed study is usually used to record the prevailing speed of reasonable drivers.

Speed limits are also established to advise drivers of conditions which may not be readily apparent to a reasonable driver. For this reason, collision history, roadway conditions, traffic characteristics, and land use must also be analyzed before determining speed limits. Speed limit changes are usually made in coordination with physical changes in roadway conditions or roadside developments. Unusually short zones of less than one-half mile in length should be avoided to reduce driver confusion.

Additionally, it is generally accepted that speed limits cannot be successfully enforced without voluntary compliance by a majority of drivers. Consequently, only the driver whose behavior is clearly out of line with the normal flow of traffic is usually targeted for enforcement.

#### **ELEMENTS OF THE ENGINEERING AND TRAFFIC SURVEY**

The three basic elements of the Engineering and Traffic Survey are discussed in more detail below.

#### Speed Sampling

Existing vehicle speeds are surveyed by a certified radar operator with a calibrated radar unit in an unmarked vehicle. Speed samples are taken for each segment representing a statistically significant sample of current traffic. This data is then evaluated to identify the distribution of speeds. A key element in the evaluation is the identification of the 85th percentile speed. The 85th percentile speed is the speed at or below which 85 percent of the traffic travels. This threshold represents what is historically found to be a safe and reasonable speed for most drivers based on common roadway conditions. Therefore, a speed limit is established at the nearest 5-mile per hour (mph) increment to the 85th percentile speed, except as shown in the two options below from the MUTCD:

Option 1: The posted speed may be reduced by 5 mph from the nearest 5 mph increment of the 85<sup>th</sup>-percentile speed, in compliance with CVC Section 627 and 22358.5.

Option 2: For cases in which the nearest 5 mph increment of the 85<sup>th</sup>-percentile speed would require a rounding up, then the speed limit may be rounded down to the nearest 5 mph increment below the 85<sup>th</sup> percentile speed, if no further reduction is used. Refer to CVC Section 21400(b).

If the speed limit to be posted has had the 5 mph reduction applied, then an E&TS shall document in writing the conditions and justification for the lower speed limit. The reasons for the lower speed limit shall be in compliance with CVC Section 627 and 22358.5

The following examples are provided to explain the application of these speed limit criteria:

- A. Using Option 1 above and first step is to round down: If the 85<sup>th</sup> percentile speed in a speed survey for a location was 37 mph, then the speed limit would be established at 35 mph since it is the closest 5 mph increment to the 37 mph speed. As indicated by the option, this 35 mph established speed limit could be reduced by 5 mph to 30 mph if conditions and justification for using this lower speed limit are documented in the E&TS.
- B. Using Option 1 above and first step is to round up: If the 85<sup>th</sup> percentile speed in a speed survey for a location was 33 mph, then the speed limit would be established at 35 mph since it is the closest 5 mph increment to the 33 mph speed. As indicated by the option, this 35 mph speed limit could be reduced by 5 mph to 30 mph if the conditions and justification for using this lower speed limit are documented in the E&TS.
- C. Using Option 2 above and first step is to round up: If the 85<sup>th</sup> percentile speed in a speed survey for a location was 33 mph, instead of rounding up to 35 mph, the speed limit can be established at 30 mph, but no further reduction can be applied.

#### **Conditions Not Readily Apparent to Motorists**

Each street segment is field inspected to identify roadway conditions that may not be readily apparent to motorists. A determination is made whether any conditions are significant and warrant the recommendation of the speed limit 5 mph or more below the basic speed limit. It is important to note that the California MUTCD recommends exercising great care when establishing speed limits 5 mph or more below the basic speed limit.

#### **SURVEY CONDITIONS**

#### **SURVEY LOCATIONS**

The procedures described below describe the criteria and methods used to survey selected streets within the City of Hercules. The specific location of the radar speed survey for each street segment was selected after considering the following:

- 1. Minimum stop sign and traffic signal influence.
- 2. Minimum visibility restrictions.
- 3. Non-congested traffic flow away from intersections and driveways.
- 4. Minimum influence from curves or other roadway conditions that would affect the normal operation of a vehicle.

#### **DATA COLLECTION**

Data of existing conditions was obtained including prevailing speed of vehicles and general roadway conditions within the community. Field reviews were conducted between May and August 2017.

#### **Speed Data**

Speed measurements were conducted in May and August 2017. All surveys were conducted in good weather conditions on a typical weekday, with school still in session. The radar unit was operated from an unmarked vehicle to minimize any influence on driver behavior. Typically, a minimum sample size of 100 vehicles or the total samples during a maximum period of 2 hours were obtained for each segment. Traffic speeds in both directions were recorded for individual segments.

#### **Field Review Data**

In June 2017, a field review was conducted for each of the selected street segments in the City with consideration for the following factors:

- 1. Street width and alignment (design speed);
- 2. Pedestrian activity and traffic flow characteristics;
- 3. Number of lanes and other channelization and striping patterns;
- 4. Frequency of intersections, driveways, and on-street parking;
- 5. Location of stop signs and other regulatory traffic control devices;
- 6. Visibility obstructions;
- 7. Land use and proximity to schools;
- 8. Pedestrian and bicycle usage;
- 9. Uniformity with existing speed zones and those in adjacent jurisdictions; and
- 10. Any other unusual condition not readily apparent to the driver.

#### CRITERIA

Survey data was complied and analyzed to determine the recommended speed limit in accordance with several criteria contained in The California Manual on Uniform Traffic Control Devices (CA MUTCD) dated November 2014. Some of the criteria used are:

- A. The critical speed or 85th percentile speed is that speed at or below which 85 percent of the traffic is moving. This speed is the baseline value in determining what the majority of drivers believe is safe and reasonable. Speed limits set higher than the critical speed are not considered reasonable and safe. Speed limits set lower than the critical speed make a large number of reasonable drivers "unlawful," and do not facilitate the orderly flow of traffic. The "basic speed limit" is the nearest 5 mph increment to the 85th percentile speed.
- B. The 10 mph pace speed is the 10 mph increment that contains the highest percentage of vehicles. It is a measure of the dispersion of speeds across the range of the samples surveyed. An accepted practice is to keep the speed limit within the 10 mph pace while considering the critical speed and other factors that might require a speed lower than the critical speed.
- C. When necessary, the collision rate for a street segment was compared to average collision rates that can be reasonably expected to occur on streets and highways in other jurisdictions, in proportion to the volume of traffic per lane mile. These average collision rates have been developed by the State of California and are considered reasonable for use in the City of Hercules.

#### RESULTS AND RECOMMENDATIONS

The Engineering and Traffic Survey Forms, presented in Appendix A, illustrate results of a thorough evaluation of the available data and recommend a speed limit for each street segment surveyed. A complete summary of all recommendations is shown in Table 2. In each case, the recommended speed limit was consistent with the prevailing behavior as demonstrated by the radar speed measurements. Typically, a speed limit in the upper range of the 10-mile pace was selected unless a collision rate significantly higher than expected was discovered or roadway conditions not readily apparent to the driver were identified. Any segments with recommended speed limits 5 mph or more below the basic speed limit are fully explained later in this report.

The Legislature, in adopting Section 22358.5 of the CVC, has made it clear that physical conditions, such as width, curvature, grade and surface conditions, or any other condition readily apparent to a driver, in the absence of other factors, would not be the basis for special downward speed zoning. In these cases, the basic speed law (CVC Section 22350) is sufficient to regulate such conditions.

The recommendations contained in this Report are intended to establish prima facie speed limits. They are not intended to be absolute for all prevailing conditions. All prima facie

speed violations are actually violations of the basic speed law (Section 22350 of California Vehicle Code). This statute states that a person shall not drive a vehicle at a speed greater than is safe having regard for traffic, roadway, and weather conditions. A prima facie limit is intended to establish a maximum safe speed under normal conditions.

Table 1 identifies the street segments with recommended changes in posted speed limits and Table 2 summarizes the recommendations for all surveyed segments. See Appendix A for the complete Engineering and Traffic Survey for the segments presented in Table 2.

#### LEGISLATIVE REFERENCES

#### APPLICABLE SECTIONS OF CALIFORNIA VEHICLE CODE

SECTION 1. Section 627 of the Vehicle Code:

Section 627.

- (a) "Engineering and traffic survey," as used in this code, means a survey of highway and traffic conditions in accordance with methods determined by the Department of Transportation for use by state and local authorities.
- An engineering and traffic survey shall include, among other requirements deemed (b) necessary by the department, consideration of all of the following:
  - Prevailing speeds as determined by traffic engineering measurements. (1)
  - (2)Accident records.
  - (3) Highway, traffic, and roadside conditions not readily apparent to the driver.
- (c) When conducting an engineering and traffic survey, local authorities, in addition to the factors set forth in paragraphs (1) to (3), inclusive, of subdivision (b) may consider all of the following:
  - (1) Residential density, if any of the following conditions exist on the particular portion of highway and the property contiguous thereto, other than a business district:
    - Upon one side of the highway, within a distance of a quarter of a mile, the a. contiguous property fronting thereon is occupied by 13 or more separate dwelling houses of business structures.
    - Upon both sides of the highway, collectively, within a distance of a guarter of b. a mile, the contiguous property fronting thereon is occupied by 16 or more separate dwelling houses or business structures.
    - The portion of highway is longer than one-quarter of a mile but has the ratio C. of separate dwelling houses or business structures to the length of the highway described in either subparagraph (A) or (B).
  - (2)Pedestrian and bicyclist safety.

#### **Basic Speed Law**

22350. No person shall drive a vehicle upon a highway at a speed greater than is reasonable or prudent having due regard for weather, visibility, the traffic on, and the surface and width of, the highway, and in no event at a speed which endangers the safety of persons or property.

#### **Speed Law Violations**

Section 22351.

- The speed of any vehicle upon a highway not in excess of the limits specified in Section (a) 22352 or established as authorized in this code is lawful unless clearly proved to be in violation of the basic speed law.
- The speed of any vehicle upon a highway in excess of the prima facie speed limits in Section (b) 22352 or established as authorized in this code is prima facie unlawful unless the defendant

establishes by competent evidence that the speed in excess of said limits did not constitute a violation of the basic speed law at the time, place and under the conditions then existing.

#### **Prima Facie Speed Limits**

Section 22352.

The prima facie limits are as follows and shall be applicable unless changed as authorized in this code and, if so changed, only when signs have been erected giving notice thereof:

- (a) Fifteen miles per hour:
  - (1) When traversing a railway grade crossing, if during the last 100 feet of the approach to the crossing the driver does not have a clear and unobstructed view of the crossing and of any traffic on the railway for a distance of 400 feet in both directions along such railway. This subdivision does not apply in the case of any railway grade crossing where a human flagman is on duty or a clearly visible electrical or mechanical railway crossing signal device is installed but does not then indicate the immediate approach of a railway train or car.
  - (2) When traversing any intersection of highways, if during the last 100 feet of the driver's approach to the intersection, the driver does not have a clear and unobstructed view of the intersection and of any traffic upon all of the highways entering the intersection for a distance of 100 feet along all those highways, except at an intersection protected by stop signs or yield right-of-way signs or controlled by official traffic control signals.
  - (3) On any alley.
- (b) Twenty-five miles per hour:
  - (1) On any highway other than a state highway, in any business or residence district unless a different speed is determined by local authority under procedures set forth in this code.
  - (2) When approaching or passing a school building or the grounds thereof, contiguous to a highway and posted with a standard "SCHOOL" warning sign, while children are going to or leaving the school either during school hours or during the noon recess period. The prima facie limit shall also apply when approaching or passing any school grounds which are not separated from the highway by a fence, gate or other physical barrier while the grounds are in use by children and the highway is posted with a standard "SCHOOL" warning sign. For purposes of this subparagraph, standard "SCHOOL" warning signs may be placed at any distance up to 500 feet away from school grounds.
  - (3) When passing a senior center or other facility primarily used by senior citizens, contiguous to a street other than a state highway and posted with a standard "SENIOR" warning sign. A local authority may erect a sign pursuant to this paragraph when the local agency makes a determination that the proposed signing should be implemented. A local authority may request grant funding from the Pedestrian Safety Account pursuant to Section 894.7 of the Streets and Highways Code, or any other grant funding available to it, and use that grant funding to pay for the erection of those signs, or may utilize any other funds available to it to pay for the erection of those signs, including, but not limited to, donations from private sources.

#### Increase of Local Speed Limits to 65 Miles Per Hour

Section 22357.

- (a) Whenever a local authority determines upon the basis of an engineering and traffic survey that a speed greater than 25 miles per hour would facilitate the orderly movement of vehicular traffic and would be reasonable and safe upon any street other than a state highway otherwise subject to a prima facie limit of 25 miles per hour, the local authority may by ordinance determine and declare a prima facie speed limit of 30, 35, 40, 45, 50, 55 or 60 miles per hour or a maximum speed limit of 65 miles per hour, whichever is found most appropriate to facilitate the orderly movement of traffic and is reasonable and safe. The declared prima facie or maximum speed limit shall be effective when appropriate signs giving notice thereof are erected upon the street and shall not thereafter be revised except upon the basis of an engineering and traffic survey. This section does not apply to any 25 mile per hour prima facie limit, which is applicable when passing a school building or the grounds thereof or when passing a senior center or other facility primarily used by senior citizens.
- (b) This section shall become operative on the date specified in subdivision (c) of Section 22366.

#### **Downward Speed Zoning**

Section 22358.5.

It is the intent of the Legislature that physical conditions such as width, curvature, grade and surface conditions, or any other condition readily apparent to a driver, in the absence of other factors, would not require special downward speed zoning, as the basic rule of Section 22350 is sufficient regulation as to such conditions.

#### **Boundary Line Streets**

Section 22359.

With respect to boundary line streets and highways where portions thereof are within different jurisdictions, no ordinance adopted under Sections 22357 and 22358 shall be effective as to any such portion until all authorities having jurisdiction of the portions of the street concerned have approved the same. This section shall not apply in the case of boundary line streets consisting of separate roadways within different jurisdictions.

#### **Speed Trap Prohibition**

Section 40801.

No peace officer or other person shall use a speedtrap in arresting, or participating or assisting in the arrest of, any person for any alleged violation of this code nor shall any speed trap be used in securing evidence as to the speed of any vehicle for the purpose of an arrest or prosecution under this code.

#### **Speed Trap**

Section 40802.

- (a) A "speed trap" is either of the following:
  - (1) A particular section of a highway measured as to distance and with boundaries marked, designated, or otherwise determined in order that the speed of a vehicle may be calculated by securing the time it takes the vehicle to travel the known distance.
  - (2) A particular section of a highway with a prima facie speed limit that is provided by this code or by local ordinance under subparagraph (A) of paragraph (2) of subdivision (a) of Section 22352, or established under Section 22354, 22357, 22358, or 22358.3, if that prima facie speed limit is not justified by an engineering and traffic survey conducted within five years prior to the date of the alleged violation, and enforcement of the speed limit involves the use of radar or any other electronic device that measures the speed of moving object. This paragraph does not apply to a local street, road, or school zone.
- (b)(1) For purposes of this section, a local street or road is one that is functionally classified as "local" on the "California Road System Maps," that are approved by the Federal Highway Administration and maintained by the Department of Transportation. When a street or road does not appear on the "California Road System Maps," (see Appendix C) it may be defined as a "local street or road" if it primarily provides access to abutting residential property and meets the following three conditions:
  - (A) Roadway width of not more than 40 feet.
  - (B) Not more than one-half of a mile of uninterrupted length. Interruptions shall include official traffic control signals as defined in Section 445.
  - (C) Not more than one traffic lane in each direction.
  - (2) For purposes of this section "school zone" means that area approaching or passing a school building or the grounds thereof that is contiguous to a highway and on which is posted a standard "SCHOOL" warning sign, while children are going to or leaving the school either during school hours or during the noon recess period. "School zone" also includes the area approaching or passing any school grounds that are not separated from the highway by a fence, gate, or other physical barrier while the grounds are in use by children if that highway is posted with a standard "SCHOOL" warning sign.
- (c)(1) When all the following criteria are met, paragraph (2) of this subdivision shall be applicable and subdivision (a) shall not be applicable:
  - (A) When radar is used, the arresting officer has successfully completed a radar operator course of not less than 24 hours on the use of police traffic radar, and the course was approved and certified by the Commission on Peace Officer Standards and Training.
  - (B) When laser or any other electronic device is used to measure the speed of moving objects, the arresting officer has successfully completed the training required in subparagraph (A) and an additional training course of not less than two hours approved and certified by the Commission on Peace Officer Standards and Training.

- (C)(i) The prosecution proved that the arresting officer complied with subparagraphs (A) and (B) and that an engineering and traffic survey has been conducted in accordance with subparagraph (B) of paragraph (2). The prosecution proved that, prior to the officer issuing the notice to appear, the arresting officer established that the radar, laser, or other electronic device conformed to the requirements of subparagraph (D).
  - (ii) The prosecution proved the speed of the accused was unsafe for the conditions present at the time of alleged violation unless the citation was for a violation of Section 22349, 22356, or 22406.
- (D) The radar, laser, or other electronic device used to measure the speed of the accused meets or exceeds the minimal operational standards of the National Traffic Highway Safety Administration, and has been calibrated within the three years prior to the date of the alleged violation by an independent certified laser or radar repair and testing or calibration facility.
- (2) A "speed trap" is either of the following:
  - (A) A particular section of a highway measured as to distance and with boundaries marked, designated, or otherwise determined in order that the speed of a vehicle may be calculated by securing the time it takes the vehicle to travel the known distance.
  - (B)(i) A particular section of a highway or state highway with a prima facie speed limit that is provided by this code or by local ordinance under subparagraph (A) of paragraph (2) of subdivision (a) of Section 22352, or established under Section 22354, 22357, 22358, or 22358.3, if that prima facie speed limit is not justified by an engineering and traffic survey conducted within one of the following time periods, prior to the date of the alleged violation, and enforcement of speed limit involves the use of radar or any other electronic device that measures the speed of moving objects:
    - (I) Except as specified in subclause (II), seven years.
    - If an engineering and traffic survey was conducted more than seven years (II)prior to the date of the alleged violation, and a registered engineer evaluates the section of the highway and determines that no significant changes in roadway or traffic conditions have occurred including, but not limited to, changes in adjoining property or land use, roadway width, or traffic volume, 10 years.
    - This subparagraph does not apply to a local street, road, or school zone.

#### **Speed Trap Evidence**

Section 40803.

No evidence as to the speed of a vehicle upon a highway shall be admitted in any court upon (a) the trial of any person in any prosecution under this code upon a charge involving the speed of a vehicle when the evidence is based upon or obtained from or by the maintenance or use of a speedtrap.

- (b) In any prosecution under this code of a charge involving the speed of a vehicle, where enforcement involves the use of radar or other electronic devices which measure the speed of moving objects, the prosecution shall establish, as part of its prima facie case, that the evidence or testimony presented is not based upon a speed trap as defined in paragraph (2) of subdivision (a) of Section 40802.
- (c) When a traffic and engineering survey is required pursuant to paragraph (2) of subdivision (a) of Section 40802, evidence that a traffic and engineering survey has been conducted within five years of the date of the alleged violation or evidence that the offense was committed on a local street or road as defined in paragraph (2) of subdivision (a) of Section 40802 shall constitute a prima facie case that the evidence or testimony is not based upon a speed trap as defined in paragraph (2) subdivision (a) of Section 40802.


# APPENDIX B Survey Equipment

This project was completed for \$694,325, slightly more than the original construction contract of \$689,906 and well below the 10% contingency amount of \$758,896.

The funding modification consists of swapping \$140,000 in new SB 1 funding with gas tax funding, thereby reducing the gas tax funding contribution from \$200,000 to \$60,000. The budget amendment to incorporate the SB 1 funding into the adopted FY17-18 Budget was approved by Council at the October 10, 2017 meeting.

Additionally, it is anticipated approximately \$68,000 will be received from PG&E due to savings from coordinating the slurry seal work with PG&E's scheduled maintenance work, which consisted of trenching for gas service line and main replacements. PG&E agreed to reimburse the City for their share of cost for sealing over their trench patches as a condition of approval for their encroachment permit. The savings will be used to reimburse the Measure J Funds.

#### **DISCUSSION:**

The 2017 Pavement Maintenance construction contract was awarded to O.C Jones for the low bid amount of \$689,906 at the June 11, 2017 Council meeting. Work began early September and the project was substantially completed late October.

The Project slurry sealed various streets in Hercules and included asphalt repair, crack sealing, and striping. Specific locations that were slurry sealed are shown on the attached Street Maintenance Location Map and include segments of Mandalay Avenue, Grenadine Way, Turquoise Drive, Alfred Nobel Drive, James Watson Drive, Redwood Road, Violet Road, Lupine Road, Manzanita Place, Nutmeg Court, Dogwood Court, and Cottonwood Court. They were selected based upon recommendations from the City's pavement management program, a visual inspection, coordination with PG&E underground work, and contractor logistics with the goal of most effectively utilizing maintenance funding to preserve the City's roadway network.

A similar sized road maintenance project is planned for next summer.



Planning, Building, and Engineering Project Management Services

#### **RECOMMENDED ACTION:**

Adopt a resolution authorizing the City Manager to execute Contract Amendment No. 3 with Municipal Resources Group for an additional \$75,000, for a total contract amount not to exceed \$300,000 (which started as \$75,000, with 2 additional \$75,000 amendments already approved for an existing \$225,000) for continued project management consulting services on development funded projects & programs, general plan related updates, planning related field inspections and conditions of approval verifications, and engineering special assignments as needed to finish out the 2017/18 Fiscal Year.

#### FISCAL IMPACT OF RECOMMENDATION:

The requested allocation of an additional \$75,000 for the extension of MRG's consulting services is anticipated to be either entirely reimbursable by development funded projects & programs, general plan update fees, building permit fees or from gas tax funds on engineering special assignments. As such, this contract extension will have no impact on the City's General Fund. Accounts that will likely be utilized to fund the proposed \$75,000 contract extension include the following: the City's General Plan Update Fee which is an impact fee collected on all building permits issued in the City, infrastructure funding such as grants utilized to manage the Regional Intermodal Transportation Center or gas tax, and planning application fees and deposits collected from developers that are used to pay for the City's cost to review development projects, and building permit fees.

#### **DISCUSSION:**

The City's current contract with MRG for an amount of \$75,000 was originally approved by the City Council in November, 2014 for the purpose of providing a range of services to the City, including planning, property management, and property transfer services. This contract was amended in October 2015 with an additional \$75,000 being allocated. The contract was amended again in February 2017 for an additional \$75,000 for a total of \$225,000. Those earlier services

were provided to the City by the MRG consultant Alan Wolken. In June 2016, Victor Carniglia of MRG replaced Alan Wolken, and Mr. Carniglia is now working for the City under the existing contract.

MRG consultants have the advantage of bringing to a local jurisdiction many years of relevant, progressively responsible municipal experience (over 35 years of such experience in the case of Mr. Carniglia). This assistance has proven to be very beneficial in assisting the City's Planning and Public Works Departments in carrying out day to day, as well as longer range tasks that otherwise would not have been able to be completed in a timely manner, particularly taking into account current staffing levels. Examples of tasks that the City expects MRG to perform under this contract amendment include the following:

- Continue to serve as the Project Manager over the City's comprehensive update of its Circulation Element to ensure successful completion and adoption. Once complete, overseeing a consultant contract to prepare the Transportation Impact Fee Study will also stem from this update.
- Continue to provide Project Manager Services to assist the Planning Director process development applications (which are paid by developer fees) by providing project review and coordination of necessary services to ensure that current and anticipated project applications are reviewed and processed in a comprehensive and timely manner. This currently includes the Bayfront Waterfront applications and the Lorenzeni Auto Service/Mini Storage projects but may include others.

- Provide ongoing staff assistance working with the East Bay Regional Park District to ensure the City receives the appropriate reimbursements for the Bay Trail and other related projects.





COMMISSION/SUBCOMMITTEE ACTION AND RECOMMENDATION: Not applicable.

**FISCAL IMPACT OF RECOMMENDATION:** None as a result of this item though the need to address operating deficits, cumulative deficits, and the cost of streetlight replacement remains an urgent matter in a number of the Zones in the Landscape & Lighting District No. 83-2.

**DISCUSSION:** The City Council received and discussed an update on Landscape & Lighting Districts at the November 14, 2017 meeting (Attachment 1 – Staff Report from November 14, 2017). This report was provided in follow-up to the mostly unsuccessful effort earlier this year to increase assessments in a number of Zones.

On November 14<sup>th</sup>, one of the items which the City discussed was the option to undertake the Proposition 218 process to have the assessments increased to address the highest priority needs of eliminating operating deficits, cumulative deficits, and street light replacement. The Council requested that staff return with information about the timing and costs to undertake this process again possibly in 2018 or 2019.

Each year we do have to undertake the normal renewal process with a CPI inflator, and that process generally costs approximately \$24,000 which is already budgeted. The estimated incremental cost for the Assessment Engineer to undertake the Prop 218 process for the four or five Zones discussed above is between \$20,000 and \$24,000. These costs are not budgeted and a funding source would need to be identified.

There are additional elements or activities which can and perhaps should be done as part of any Prop 218 process. Elements of these additional activities could be done in January and February and concurrent with the other formal steps outlined above.

The above schedule does not include polling, which may be desirable before proceeding, or additional public education and outreach. This year, the cost of having a firm assist us with the public education and outreach materials was just over \$30,000, though that did not include any polling. The estimated cost of a professional poll would be \$25,000 to \$30,000. The City would have to be prepared to grapple with the possibility that the polling results would indicate support for assessment increases which would not provide the resources required to eliminate the operating deficits, cumulative deficits, and/or allow for streetlight replacement. Though it would allow for more informed decision making nonetheless.

As identified above, polling may help refine how the proposed assessment increases would need to be packaged to ensure an understanding of the need. The estimated cost of having a firm assist us with another education and outreach effort building off of this year's efforts is a minimum of \$15,000, plus \$6,000 to \$8,000 for graphics support. In addition, the cost to produce each mailing, with three or four being optimal, would be approximately \$1,500 each or another \$6,000. These costs are also not budgeted and a funding source would need to be identified.

It is important to note that the use of public resources is limited to education and outreach. No public funds can be used for advocacy. As with any "election" type of effort, success is most likely when elected officials and community members advocate for the measures using their time and resources. As such, if the Council were to embark on another Proposition 218 effort, efforts to develop advocacy groups would need to be undertaken by elected officials and community leaders.

The City is also committed to ensuring that the services provided by the Landscape & Lighting Assessment Districts are being provided in a cost effective manner. Recently, the City Council approved a major tree inspection and maintenance contract to address some deferred maintenance issues with the trees in the Districts and Zones. In addition, the Public Works Department has restructured how the landscape maintenance contracts are being managed and overseen. A staff member has been assigned to regularly review the work being done with a check-list and regular meetings with the contractor.

An additional item of discussion on November 14<sup>th</sup> was the proposal to undertake a pilot streetlight replacement project in those Zones which have the funds available or which can afford to finance the replacements, or where a portion of the streetlights could be replaced with available reserves. Staff has been working to advance that effort.

The Pilot will see streetlights replaced as follows:

The replacement Streetlights which meet PG & E's standard for the City-owned and PG & E maintained lights, and those which match the others in the City, are available from a single manufacturer. The manufacturer advises that once ordered, the replacement poles and fixtures will be available in six to eight weeks. The City has two options as to how to proceed with the Pilot streetlight replacement project:

#### **Turnkey Contract**

On this basis, the City would develop bid specifications and solicit bids from contractors who would procure the new street lights, remove the existing streetlights, and install the new streetlights. Most likely, this option would be 20-30% more costly as the contractors would purchase through a distributor who add a mark-up on the streetlights and not directly from the manufacturer. However, it would have the contractor fully responsible for the completion of the project and they would provide a contractor warranty for the work in addition to the manufacturer warranty. It would also involve a single staff procurement effort and the City would look to only one party for successful completion of the project.

#### **Direct Purchase**

For this option, the City would purchase the lights directly from the manufacturer under their direct purchase program which the City has participated in before. The lights and fixtures would be ordered and once received, stored at the Corporation Yard until a contract for the removal of the old streetlights and the installation of the new streetlights could be bid and awarded. These efforts would be timed to try to ensure the replacement lights are not stored for a long period of time.

City staff have consulted with the City Attorney's Office in regard to the pros and cons of each approach. While the turnkey contract approach is likely to involve less risk if the project has performance issues or disputes, the possible cost savings and the nature of the project has resulted in staff deciding to utilize the direct purchase approach. To ensure success with this approach, resources will have to be utilized to ensure good management of the project and regular inspections as the project proceeds. In addition, the pilot project will flesh out what rebates may be available and what operating cost savings may be generated once completed and placed into operation. The Council has indicated a preference to have the Pilot Streetlight Replacement Project completed before any Prop 218 process were undertaken. Realistically, that may be difficult to do for a Prop 218 process in 2018, but most certainly could be completed well before a 2019 process.

#### COMMISSION/SUBCOMMITTEE ACTION AND RECOMMENDATION:

This report was presented to the Finance Commission on November 16, 2017.

#### FISCAL IMPACT OF RECOMMENDATION:

The discussion section below gives a synopsis of the FY 2017-18 First Quarter Report for the General Fund and Wastewater Fund.

#### **DISCUSSION:**

The purpose of the First Quarter FY 2017-18 Budget Review is to determine if the City's revenues and expenditures for the first quarter is approximately at the 25 percent mark. Departments are charged to operate within their adopted budgets, to utilize already appropriated funding, and to manage within their overall budget.

The First Quarter FY 2017-18 budget report summarizes the City's general fund and wastewater fund's overall financial position for the fiscal year through September 30, 2017. The City's overall revenue and expenditure will be discussed in greater detail during the Mid-Year Budget Review scheduled for Council consideration in February 2018.

With 25 percent of the year complete, General Fund revenues and expenditures are on track with the budgeted amount.

#### **GENERAL FUND**

The chart on the next page shows the FY 2016-17 budget, encumbrances, YTD Actuals for the first quarter, Balance, Percentage Collected and Expended, and the Year-End Estimate for the General Fund.

The majority of General Fund revenue comes from taxes in the following categories:

- Business License Fees
- Document Transfer Tax
- Franchise
- Property Taxes
- Transient Occupancy Tax
- Utility Users Tax

#### **General Fund - Revenue Analysis**

- 1. The Business Licenses revenues collected is only 4% in the first quarter as most of the business licenses are usually collected in the third quarter of the year.
- 2. Taxes are received in December (55%), April (40%), and June (5%) of each fiscal year.
- 3. The Transfer Occupancy Tax (TOT) collected in the first quarter is at 39%. There is an increased in TOT payments in this fiscal year.
- 4. Taxes are received in December (55%), April (40%), and June (5%) of each fiscal year.
- 5. The Fines & Forfeiture for Vehicle Code Fines revenue collected is at 66% in the first quarter due to the addition of a ½ time Enforcement Officer and increased parking enforcement activities.
- 6. The Parks and Recreation revenue collected is at 32% in the first quarter as most parks and recreation revenues are received in the first quarter of each fiscal year.
- 7. The Miscellaneous revenue received is at 73% in the first quarter due to a revenue being posted to general fund instead of the Facility Maintenance fund. The \$68,464 revenue will be moved to the Facility Maintenance Fund in the second quarter.
- 8. The transfers in will be completed at the fiscal year end.

#### **General Fund - Expenditure Analysis**

- 9. The Salaries and Wages in the first quarter are at 29%, which is slightly higher than 25%, due to the one-time retention payment and the increase in salaries and benefits incurred in July 2017.
- 10. The Insurance Services amounts are at 74% in the first quarter due to the fact that most of the annual insurance premiums are due in the first quarter of each fiscal year.
- 11. The utility services are at 12% in the first quarter since only two months of utility bills have been received and processed in the first quarter.
- 12. The Other Miscellaneous expenditures are at 37% in the first quarter but is projected to stay within the budget of \$257,352 at the fiscal year end.
- 13. The Capital Outlay for Fixed Asset amount is at 2% in the first quarter but is projected to be spent 100% by fiscal year end.
- 14. The Capital Outlay Improvement item will need a budget adjustment as part of the \$100K was a carryforward from FY16-17.
- 15. The Transfers Out of \$847,366 will be transferred at the end of the fiscal year.

- 1. The Charges for Services for the Sewer Enterprise Fund received in December (55%), April (40%), and June (5%) with the property taxes.
- 2. The transfers in from other sources will be process at the fiscal year end.

#### Wastewater Fund - Expenditure Analysis

- 3. The salaries and benefits are at 34% in the first quarter. The FY17-18 year-end estimate is \$188K. An additional \$43K would be needed to cover the increase in salaries and benefits during the mid-year budget adjustment.
- 4. The salaries and wages are at 33% in the first quarter. The FY17-18 year-end estimate is \$414K. An additional \$83K would be needed to cover the increase in salaries and wages during the mid-year budget adjustment.
- 5. The Miscellaneous Services and Professional Services accounts should be rolled up and looked at on the aggregate level. The year-end estimate for both expenditure accounts are expected to be below the budgeted amounts.
- 6. The Utility Services are at 32% in the first quarter. The FY17-18 year-end estimate is \$98K. An additional \$24K would be needed to cover the increase in Utility Services costs during the mid-year budget adjustment.
- 7. The Utility expenses are at 33% in the first quarter. The FY17-18 year-end estimate is \$414K. An additional \$83K in appropriation would be needed to cover the increase in salaries and wages during the mid-year budget adjustment.
- 8. The Capital Outlay Depreciation expenses budget need to be adjusted during the midcycle. The budgeted amount in depreciation expense is \$31K and should be increased to \$483K during the midcycle process as there will be more depreciation expenses being captured by the end of the fiscal year.
