Dear Council Member:

Please address the followings to CLOSED SESSION ITEM III.1, DAVID BIGGS'S JOB EVALUATION, WITH ATTACHED CLAIM AS EXHIBIT AND REQUEST TO TERMINATE, ACCORDING TO THE CONTRACT MAY 11, 2014 AND VIDEO CONFIRMATION SESSION AT JUNE 10, 0214. BESIDES, DAVID BIGGS HAS NOT PASSED THE BACKGROUND CHECK. WHEN SOMEONE IS NOT SUBMITTING THE BACKGROUND CHECK, IT IS ASSUMED AS IT IS DISQUALIFIED TO BE A CITY EMPLOYEE.

1. Please terminate David Cary Biggs, who embezzled and left me IRS Lien \$1,125,567.98, dated December 30, 2019, based on the reported embezzled money found in the Clifford Allen Larson, LLP, Audit;

I'm including the Claim, "Wrongful Death" of my adopted son/nephew' whose money approximately \$150K was used when solicited by the City employee in organizing and paying for expenditure.—This is included in the Tax Returned, on which the IRS Lien was based.

2. David Biggs is subject to termination because he refused to disclose the Embezzled money in his file and refused to audit on the city account, that is questioned by city council with a 'projected Surplus' projected without disclosing embezzled money, and after having embezzled the money "\$3,338,889" ("2.5M" and "\$805,702").

3. Please remove the City website Public Comment on Pil Orbison Lawsuit. This is libelous and intended to false claim with organized crime.

4. You are liable to a cause of my nephew's death after his loan that was disclosed as a "Promissory Note" in the former case msc16-00638 (Pil Orbison V. City of Hercules.)

5. Please remove Judy Yamamoto from city committee appointment because of conflict of Interest and Judy's Hacking Pil's emails and trolling, which is pending court action.

It is very important city not to abuse Hercules citizens, and the business owners have their right to operate business without being abused financially and mentally.
