RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HERCULES AUTHORIZING THE CITY MANAGER TO EXECUTE ANNUAL MAINTENANCE CONTRACTS WITH PACIFIC SITE MANAGEMENT FOR CITYWIDE LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT NO. 83-2 FOR AN AMOUNT OF \$332,898, VICTORIA BY THE BAY LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT NO. 2002-1 FOR AN AMOUNT OF \$135,911, HERCULES VILLAGE (PROMENADE) LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT NO. 2002-2 FOR AN AMOUNT OF \$45,302, BAYWOOD LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT NO. 2004-1 FOR AN AMOUNT OF \$34,196, THE HERCULES TRANSIT CENTER FOR AN AMOUNT OF \$13,273 AND EXECUTE AN ANNUAL MAINTENANCE CONTRACT WITH NEW IMAGE LANDSCAPE COMPANY FOR BAYSIDE LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT NO. 2005-1 FOR AN AMOUNT OF \$18,500

WHEREAS, the City of Hercules contracts for landscaping services for the 5 Lighting and Landscaping Assessment Districts on an annual basis; and

WHEREAS, requests for proposals for landscaping services for the 5 Landscaping and Lighting Assessment Districts and Hercules Transit Center were issued on May 30, a mandatory pre-proposal meeting was conducted on June 6 and 4 contractors attended, and 2 contractors submitted bids which were opened on June 19, 2017; and

WHEREAS, Pacific Site Management submitted the low bids for 4 Districts and the Hercules Transit Center while New Image Landscape Company submitted the low bid for 1 District as described above; and

WHEREAS, both Pacific Site Management and New Image Landscape Company have been determined to be responsible bidders.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hercules that the City Council hereby authorizes the City Manager to execute annual maintenance contracts with:

- a. Pacific Site Management for Citywide Landscaping and Lighting Assessment District No. 83-2 for an amount of \$332,898, Victoria By The Bay Landscaping and Lighting Assessment District No. 2002-1 for an amount of \$135,911, Hercules Village (Promenade) Landscaping and Lighting Assessment District No. 2002-2 for an amount of \$45,302, Baywood Landscaping and Lighting Assessment District No. 2004-1 for an amount of \$34,196; and the Hercules Transit Center for an amount of \$13,273.
- b. New Image Landscape Company for Bayside Landscaping and Lighting Assessment District No. 2005-1 for an amount of \$18,500.
