- 1. Received and continued discussion of the Revised Proposed FY 17-18 Revenues and Expenditures Plan.
 - a. Melinda Cervantes, County Librarian, attended the Finance Commission Meeting to answer questions from the Commissioners pertaining to the

- budget. Vice Chair Freese mentioned that he would like transparency from the County for all expenditures, mainly salary and benefits costs.
- b. The Treasurer of the Hercules Library Foundation expressed his thoughts on the Library hours. The Hercules Library Foundation has been raising funds for five (5) years to maintain the library to be open for an additional five (5) hours; however, he believes that it is time to transition the responsibility to the City. The Hercules Library Foundation currently has \$39,000 and he proposed to spread the funds for three years to a total of \$13,000 per year. With this proposal, the City will only be responsible for budgeting \$31,000 annually.
- c. A Hercules resident expressed her concern in the outstanding and growing pension obligations.
- d. Vice Chair Freese motion to make a recommendation to City Council to include a Decision Package item to fund the extended Library hours to 43 hours per week and to accept the \$13,000 offer from the Hercules Library Foundation.

Second by Commissioner Charlup.

e. Chairperson Tom motion expressing concerns as to the growing deficit in the Parks & Recreation programs and to ask if the Council would like the Finance Commission to form a subcommittee to review that next year.

Second by Commissioner Charlup.

f. Vice Chair Freese motion to recommend to City Council that General Fund Balance Decision packages #3 and #4 be part of the FY 17-18 Budget.
