## General Fund Operating Budget Alternate Decision Packages

Alternate Decision Package # 18- 1: Library Extra Hours Funding — Last year the City provided \$14,000 in funding as a contribution towards The Friends of the Library and the Library Foundation costs for funding 5 extra weekly hours at the Hercules Library based on 50% of the costs for these additional hours of \$26,500 for FY 2016/17. The County Library has advised that the costs for these 5 additional hours for FY 2017/18 will be \$44,782 which is slightly above the costs in the 2015/16 FY of \$42,000. The return to this higher level of costs has been attributed to more permanent and higher paid staff being assigned to Hercules and the addition of a half-time clerk. The Council may elect to continue to provide a contribution at the same level as last year, at a higher level, or may discontinue making a contribution.

**Supplemental Information**: Attached is information provided by the County Librarian and which was shared with the Finance Commission. Given how staffing can be allocated at the \$44,782 contribution level, the Library indicates they can provide 43 hours of service or 8 extra hours. At the June 13<sup>th</sup> City Council public hearing, and at the June 19<sup>th</sup> Finance Commission meeting, representatives of the Library Foundation indicated they would be willing to commit the balance of the funds raised to date or \$39,000, to funding additional hours over three years of \$13,000 a year if the City were to commit to funding the balance needed and to continue to fund the 5 extra hours.

#### Hi David,

The first attachment is a spreadsheet showing 40 (current), 35, and 43 hour schedules for the Hercules Library. This is far more detail than we normally provide each city, but this will clarify how staffing for 40 hours can be scheduled to extend hours to 43 per week.

Each sheet has a week 1 and week 2 schedule which is important for our Labor MOU work rules. Namely, ½ staff on Friday and ½ staff on Saturday. And 2 evenings a week for 40 hour staff and 1 evening a week for 20 hour staff.

The second attachment compares the last 5 years of operating costs budgeted for the Hercules Library. To the question raised by the Finance Commission, the Hercules Library operating costs for FY2016/17 were budgeted at \$1,001,960 and per the County Auditor-Controller, the property tax revenue allocation from Hercules for the same fiscal year was estimated to be \$564,000.

I have not received any additional information about the actual calculation of property tax revenue for Hercules.
