RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HERCULES APPROPRIATING AN ADDITIONAL \$55,000 IN THE FY17-18 BUDGET FOR THE LIGHTING ASSESSMENT DISTRICT FUND (FUND 220) FOR: ZONES 1 HERCULES BY THE BAY; 3&4 THE GEMS/BIRDS; 6 VILLAGE PARKWAY; 7 THE HEIGHTS, AND; 9 BIRDS & COUNTRY RUN IN THE AMOUNT OF \$11,000 FOR EACH ZONE FOR A TOTAL AMOUNT OF \$55,000.
