#### **VI. DISCUSSION / ACTION ITEMS**

1. **Temporary Use Permit #TUP 16-08, TUP 16-09, and TUP 16-10** submitted by Holly Prinz of ABC Tree Farms LLC for a Summer Fun Zone on summer weekends, the Pumpkin Patch 7 days a week in October, and a Christmas Tree Sales lot 7 days a week in December at 4000 San Pablo Avenue at the Northeast Corner of San Pablo and Sycamore Avenues (also known as the Market Hall Site).

**Recommendation:** Consider adopting Planning Commission Resolution #16-001 approving TUP 16-08, TUP 16-09, and TUP 16-10, with the Conditions of Approval Listed Therein
