# 17-291 Safeway Shopping Center Entitlements

**Recommendation:** Conduct a Public Hearing to review the proposed Safeway Shopping Center Entitlements - to Construct a proposed 57,100 square-foot Safeway supermarket with a 2,500 square foot Safeway fueling kiosk / convenience store with 20 fuel pump station, and a 6,000 square foot commercial pad with the potential for two (2) drive-thru uses on a 6.75-acre former BART Park & Ride and Market Hall site on the northeast corner of San Pablo and Sycamore Avenues
