V. PUBLIC HEARINGS

1. 17-512 Citywide Comprehensive Circulation Element Update to the City's General Plan

After a yearlong effort of community reports and with community meetings in July, October, and December, taking into account the existing EIR, existing reports, and existing infrastructure the presentation will describe the project in more detail.

Planning Director Smyth introduces consultants including Josh Pilachowski and Erin Vaca from DKS, Victor Carniglia (project manager), Robert Reber (Assistant Planner), and Dan Doporto.

Recommended Changes from Q&A:

- Question 4: Open Space/Conservation needs to be amended to add Refugio Valley Road as Scenic road.
- Question 8: Reword Policy 1.F.2. on Truck Routes to allow better separation between bike/pedestrian and trucks.
- Modify policy 5.A.1 that City would "help direct employers to agencies and websites that can help increase their ridesharing and similar TDMs"
- Remove palm between Willow and Sycamore as Truck Routes.

- Table 5-1 add References to Figures 3-12 and 3-13 where appropriate.
- Goal 6 to improve congestion in school areas.
- On Figure 3-15 Emergency Access Routes, add "Goat Road" at Refugio Valley Road which is a fire road that connects to Alhambra Valley Rd.
- Add Policy 3.B.7 "Entryway Signage should be added to key points of entry in the City."
- Clarify Policy 1.A.3 that VMT "in addition to LOS" would be used to determine a project's air quality impacts.

Planning Commission responds with comments and questions, answered by staff and consultants.

Recommendation: Conduct a Public Hearing and upon conclusion, either 1) adopt Resolution No. 17-09 recommending the City Council's adoption of the Updated Circulation Element and the adequacy of the Negative Declaration with direction on specific changes included, if needed or 2) provide direction to staff on changes/modifications to be made to the Circulation Element and continue the Public Hearing to the Planning Commission meeting of January 16, 2018.

Motion: Continue Public Hearing to January 16, 2018 meeting for the Hercules Circulation Element.
