Mayor Kelley called for a moment of silence for the recent high school shooting in Santa Fe, Texas where 8 students and 2 teachers were fatally shot and wounding several others including one officer who is in critical condition. Mayor Kelley called upon our State and Federal Legislators to do something about gun violence in this country and stated that this is a public health emergency.

Recommendation: Open the public hearing, take public testimony, close the public hearing and adopt a Resolution amending development impact fees to incorporate the updated Rodeo-Hercules Fire Protection District levied fire facilities impact fee and amending the City's master fee schedule.

City Manager Biggs introduced the item and provided a staff report. City Attorney Tang provided additional information. City Council conducted a question and answer period.

Fire Chief Bryan Craig and Carlos Villarreal, Fire District Financial Consultant answered questions related to the fee increase.

Mayor Kelley opened the public hearing at: 8:15 p.m.

Mayor Kelley closed the public hearing at 8:21 p.m.

City Council provided final comments on the item.

Council Member de Vera made a motion to continue the public hearing and allow the Hercules-Rodeo Fire District to revisit the nexus study and bring back a revised study with supporting documents to lower the development impact fee by re-evaluating the need for a new fire station, however still meeting the needs of protecting life and addressing structural fires.

A substitute motion was made by Vice Mayor Romero to revise the Table 6 and 7 of the nexus study to remove the new Fire Station 76 and lowering the cost per square foot on Table 7 from \$990 per square foot to \$600 per square foot. After further discussion Vice Mayor Romero withdrew his substitute motion.

MOTION: A motion was made by Council Member de Vera, seconded by Council Member Esquivias, to continue the public hearing to a future City Council meeting date when a revised nexus study can be completed. The motion carried by the following vote:

Vice Mayor Romero made a motion to proceed with allowing Mesa Outdoor to submit an application for the sign. The motion was seconded by Council Member Boulanger. The motion failed 3-2.

Council Member de Vera made a motion to direct staff to issue a letter to other vendors asking if they would like to submit a letter of interest and allow a 30 day response time and if the city does not receive any letters of

interest to proceed with Mesa Outdoor submitting an application and enter into negotiations for the terms and conditions of the lease agreement. If the City receives letters of interest then proceed with a Request for Proposal for the project. This motion was seconded by Council Member Esquivias. Vice Mayor Romero made a request to Council Member de Vera who made the motion to add a stipulation that this item will come back before the City Council at the June 26th Council meeting. Council Member de Vera agreed to add that stipulation.

MOTION: A motion was made by Vice Mayor Romero, seconded by Council Member Boulanger, to approve proceeding with Mesa Outdoor for submittal of an application for an outdoor electronic sign and to enter into negotiations of the terms and conditions of the lease. The motion failed by the following vote:
