MOTION: Commissioner Ward-Jackson moved to approve the consent calendar, and Commissioner Nguyen seconded the motion. Motion passed 4-0.

1. Art Exhibit Application – for Library – Artist: Tatiana Ortiz

The exhibit would include 6 paintings of children emulating influential people or figures in history. The message behind the paintings is to explore the wonderful world of reading and books. The paintings are 16" x 20" in size, made of canvas and acrylic paints.

MOTION: Commissioner Nguyen moved to approve the exhibition of art by Tatiana Ortiz in the Library, and Commissioner Ward-Jackson seconded the motion. Motion passed 4-0.

 Brief discussion on the annual clean-up day event coming up on May 4.
- 4. Adopt-A-Park/Trial: An application was received from Ernie Sanchez for the maintenance of Duck Pond Bocce Courts. The Courts don't currently get much use because of the decomposed granite (DG) that is in between the courts. When you step on the DG it sticks to the bottom of the shoes and gets tracked into the courts. The DG scratches and slows the balls down. Ideally in the future hardscape would replace the DG material, but in the meantime, Ernie has a group of people that play in the Martinez Bocce Federation, that would like to maintain the courts in exchange for use of the courts. Some basics would need to be purchased for the courts for this to take place.

MOTION: Commissioner Ward-Jackson moved to approve the Adopt-A-Park application for Ernie Sanchez to work on the Bocce Courts at Duck Pond Park, and Commissioner Carpena seconded the motion. Motion passed 4-0.
